Shipments are F.O.B. ORIGIN, Freight On Board. 36 Hour Days LLC ships ground orders with USPS. Truck Shipments, unless a carrier is specified, are at the discretion of 36 Hour Days LLC.

### **Return Policy**

### **Unopened Merchandise**

You (the customer) may return any "unopened" products and accessories within 10 days of delivery for a full refund. You will be responsible for both the original outbound shipping charges as well as the return shipping charges.

### **Opened Merchandise**

"Opened" products and accessories can be returned within thirty days of delivery, but will be subject to a 15% restocking fee to cover testing, cleaning and repackaging expenses. You will be responsible for both the original outbound shipping charges as well as the return shipping charges. Opened items **MUST** be in saleable condition with original materials and packaging.
